

1. THE PROMOTION

The Terms and Conditions (the “**Terms**”) defined below form the basis of an offer provided by **Raw Trading (Mauritius) Ltd** (hereunder “**we**”, “**us**”, “**the Company**”, “**our**”, “**us**” and “**ourselves**” with Incorporation Number: C-187004 regulated by the Financial Services Commission of Mauritius (FSC) with the license Number: GB21026834.). By participating, clients (“**you**”, “**your**”, the “**new client**”) agree to these terms, and have the opportunity to earn a bonus upon meeting specific trading volume and deposit requirements.

2. ELIGIBILITY CRITERIA FOR CLIENT

The deposit bonus will be available only when the new clients meet the following eligibility criteria:

An eligible client must:

- 1) be a resident of Japan;
- 2) be eligible to open an account with us, which must to be set up according to the rules of the Financial Services Commission of Mauritius (FSC);
- 3) be of legal age in your jurisdiction;
- 4) be a first-time user of our trading services;
- 5) complete the initial deposit within the promotion period;
- 6) meet the trading volume and net deposit requirements in accordance with Clause 4.2;
- 7) comply with these Terms and relevant legal documents applicable to your trading account.

3. THE PROMOTION PERIOD

The Deposit Bonus Promotion is valid from August 1, 2025 to August 31, 2025 MT4 time, subject to early termination as per Clause 6.13 (hereinafter referred to as the “**Promotion Period**”).

4. HOW TO PARTICIPATE

- 4.1 To participate in this promotion as a new client, you are required to open a live trading account with IC Trading (if you do not have one prior to the commencement of this promotion);
- 4.2 New clients can qualify for a bonus only after meeting all the eligibility criteria listed below.

- 1) Minimum deposit requirement – clients must make a net deposit of at least ¥25,000 JPY (or its equivalent in the account's base currency) into their real trading account during the promotion period; and
- 2) Minimum trading volume requirement– After the initial deposit has been made, clients need to complete at least 3 lots of round-turn trades* on Forex and/or metal CFDs within 30 days of the initial deposit.

NOTE: That only Forex and metal CFDs positions that have been held for at least 5 minutes or longer time will be counted in to meet the trading volume requirement.

*During the promotion period, the Effective Deposit is calculated based on the Net deposit (Net Deposit = Deposit - Withdrawals)

*Effective positions are defined as positions with an opening time of 5 minutes or longer, with no limit on the amount of a single order. Hedging positions are not counted as effective orders.

To avoid any confusion, both the minimum deposit and trading volume requirements must be met to qualify for the deposit bonus.

5. PROMOTION REWARD RULES

- 5.1 The awarded funds will be directly credited to the trading account you specified during registration. Clients have the authority to use these funds either for further trading on MT4, MT5, or cTrader trading platforms or they may choose to withdraw the funds. Please note that the distribution of the promotion rewards will be exclusively in this manner and no alternative forms of payment will be available.
- 5.2 The promotion prize pool is determined by the participants' deposit, trading level and required period, with corresponding promotional rewards as follows:

- 5.3 During the promotion period, if the trading volume and the net deposit amount correspond to different bonus tiers, the bonus amount awarded will be determined by the lower tier met by the client.
- 5.4 You must fill out the registration by the end of August 31, 2025; failure to fill out the registration form during the promotion period will be considered a waiver.

6. OTHER TERMS AND CONDITIONS

- 6.1 The Promotion can be used in conjunction with other offers provided by us, but each promotion's requirements must be fulfilled separately;
- 6.2 By participating in this Promotion, you agree and accept to comply with these Terms and all relevant terms and conditions applicable to your trade accounts with us;
- 6.3 Each eligible client (based on ID, where the same ID is considered as the same user) is entitled to receive the bonus only once, regardless of how many accounts the individual has.
- 6.4 The maximum bonus for this promotion is ¥1,000,000 YEN;
- 6.5 To avoid misunderstanding a joint account will be considered as being one new client under this Promotion;
- 6.6 The effective deposit amount within the promotion period is calculated according to the total net deposit amount (Net deposit = Deposit -Withdrawal); the amount deposited by rebate transfer, internal transfers (from another trade accounts / IC profile) will not qualify as the effective deposits towards this promotion;
- 6.7 You are responsible for any tax consequences, if any, that may result from your participation in this Promotion;
- 6.8 Trading Forex and CFDs carries risks and may not be suitable for all investors. Losses might exceed your original investment. Before you decide to join this Promotion and invest with us, please ensure you have fully read all legal documents applicable to you and you are fully aware of the risk contained. You may obtain a copy of these legal documents from our website. Seek independent advice if necessary;
- 6.9 We shall not assume any liability for any losses incurred to any clients in connection with the Promotion, however arising, including but not limited to losses incurred from trading;
- 6.10 Clients must have genuine trading intent. We reserve the right to revoke the bonus credits should any abusive, fraudulent activities, exploitation, or lack of genuine trading intentions of this Promotion is identified;

- 6.11 Any violation of these Terms might lead to the bonus credits being canceled, or claimed back, as applicable and at our sole discretion;
- 6.12 If any client is discovered to be ineligible for the Promotion for any reason, we are entitled to at any time:
- 1) Forfeit, withdraw or withhold the bonus credits;
 - 2) Or where the bonus credit has been awarded and/or utilized, reclaim the bonus credit and/or deduct the utilized portion of the bonus credits from the client's account.

In such an event, no person shall be entitled to any payment or compensation from us;

- 6.13 We may, at our discretion, vary, amend, delete and/or add on to any of the terms, including, but not limited to, terminating this Promotion at any time without giving any reason or prior notice or assuming any liability to any client(s), and all client(s) shall be bound by such variations, amendments, deletions and/or additions;
- 6.14 We shall be the sole determiner of the interpretation of these Terms in its sole and absolute discretion;
- 6.15 At our discretion, translations of these Terms may be provided for your convenience. Please be aware that the original English version of these Terms is the definitive and legally binding document. In the event of any inconsistency or discrepancy between the English version and any translations, the English version will take precedence and will be the governing document in all aspects of this Promotion;
- 6.16 To the maximum extent permitted by law, all participants agree to keep us indemnified at all times against any liability, claims, demands, losses, damages, costs, and other related expenses resulting from or in connection with this Promotion;
- 6.17 If any provision(s) of this Terms is held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
- 6.18 Our decision in any matter in relation to this Promotion will be final and conclusive;
- 6.19 Our employees or other producers or suppliers associated with this Promotion, their advertising, printing, and publicity agencies, and their immediate family members (i.e. any person residing in the household of the aforementioned people) will not be eligible to participate in the Promotion;
- 6.20 The Terms shall be governed by and construed in accordance with the laws of Mauritius.
